January-November 2025 Accomplishments

- **Individuals Assisted:** 4,596 served via service requests, presentations, community events and meetings
- **Services Provided:** 2,309
- **Items Distributed:** 7,483 (Estimated value \$14,202)
- **Volunteer Hours Contributed:** 3,090 (Estimated value \$53,293)
- **Total Estimated Value:** \$67,495

Event Highlights

Mountain Hope Clinic Health Fair (Jan 30–31)

- ◆ Shared website resources with 75 patients.

Emergency Preparedness Clinics (Served 427 people)

- ◆ Feb 7 – King Family Library: Notarized 185 childcare and general POAs.
- ◆ Feb 28 – Iglesia Cristiana La Luz de Jesus: Provided translators and notaries; 67 POAs notarized; 21 cases referred to Catholic Charities in Knoxville.
- ◆ Mar 31 – King Family Library: Notarized 4 childcare and general POAs.
- ◆ May 10–25 – Holy Cross Church: Assisted 20 families with POAs during Emergency Preparedness presentation.
- ◆ Dec 1 – King Family Library: Notarized 103 childcare and 48 general POAs.

Child Abuse Awareness Event (Apr 4 – Wears Farm City Park)

- ◆ Engaged with 86 individuals, shared resource information, and distributed free glasses and bracelets.

Vision Clinic with Sevier County Lions Club (Apr 30, July 30, Oct 29)

- ◆ Supported 3 events providing 200 volunteer hours in translation, check-in, and patient flow.
- ◆ Served a total of 201 patients in Sevierville.

Health Fair with Sevier County Health Dept (May 6)

- ◆ Co-sponsored health fair with Sevier County Health Department and deployed 36 volunteers and translators; served 67 families.

Back-to-School Events (July, August)

- ◆ Safety and Fun Day (Jul 24, 2025): Provided 200 children with school supplies donated by TVA Credit Union.
- ◆ King Family Library/Back to School Day: Provided 300 children school supplies also donated by TVA Credit Union.
- ◆ Pigeon Forge High School Open House: Met with 40 families to discuss our services.

School Registrations

- ◆ Provided 42 interpreters across 4 Sevier County schools, assisting 161 parents with student registration.

Mountain Hope Health Fair (August 7-8)

- ◆ Helped 90 patients and provided 1,180 feminine hygiene items.

Festival of Hope Street Fair- Relay for Life (Sept 6)

- ◆ Hosted a booth with giveaways and helpful resources staffed by 2 volunteers meeting with 80 people.

Sheriff's Shindig (Sept 23)

- ◆ Hosted a booth with giveaways and resource materials; 2 volunteers met with 200 community members.

Boy and Girls Club of the Smoky Mountains – Fall Family Resource Events

- ◆ Hosted booths in Sevierville (Sep 18) and Pigeon Forge (Sep 25).
- ◆ Staffed by 2 volunteers, connecting with 320 individuals total.

Translation Hours at Community Events

- ◆ Provided nearly 695 hours translating in 2025 (YTD)

St. Mary's Legacy Clinic (Monthly)

- ◆ Provided ongoing translation support for an average of 32 patients per month

Department of Children's Services (DCS) Support (Monthly)

- ◆ Provided ongoing case management assistance averaging 10 hours per month.

Children's Health Assistance (Monthly)

- ◆ Supported 4 cases at Children's Hospital, 3 at Sevier County Health Department (SCHD), and 1 at McNabb Center.

Legal Aid & Notary Requests (Monthly)

- ◆ Responded to 441 requests for legal aid referrals.
- ◆ Handled 268 requests for notary and other document-related services.
